## CICC Postdoctoral Research Fellowship Final Report

Over the past year, I worked with Dr. Carolyn Côté-Lussier on the project titled "An investigation of the role of the stress response system and cortisol as intermediaries between environments adverse effects of early childhood and quality of life and adjustment to adulthood". Over the course of the year I have had several accomplishments.

Specifically, within the project I have done the following:

- Obtained and familiarized myself with two different longitudinal datasets: QUALITY, and the CLRP.
- I obtained spatial data from CANUE and it is currently being prepared to be incorporated into the dataset for the CLRP project.
  - o I have been learning how to use spatial data by exploring the available variables and through auditing a spatial analysis class at INRS and by consulting with colleagues that are experts in this domain.
- For the data pertaining to the QUALITY project, I have been exploring ways to create profiles for children that would incorporate anxiety and depression indicators as well as cortisol responses.
  - This was a new technique that required learning of new features in the Mplus software
  - o I will then be taking these profiled and putting them into regression models assessing the relations between them and physical environment measures
- Next, I will be performing a mediation or moderation analysis for the data in the CLRP project. This will allow me to assess the relation between childhood neighbourhoods (physical and socio-economical), cortisol responding, and adult outcomes such as educational attainment, and criminal charges.
